





1% Post Election Manual Tally Report Oakdale Joint Unified School District Special Election – March 7, 2023

Pursuant to California Elections Code 15360, The Stanislaus County Registrar of Voters conducts a random drawing to determine which ballots will be hand tallied in the 1% Manual Tally to verify accuracy of the ballot counting equipment. The random draw was conducted on **March 8, 2023**, at 11:00 a.m.

- For vote by mail ballots: 1% of batches scanned at the central count location during the semifinal canvass was randomly selected.
 - Central count utilizes three color coded scanning groups: Orange, Yellow and Green.
 - All ballots for this special election were scanned using the Orange scanning group.
 - All ballots cast at this special election were vote by mail.
