If an eligible incumbent does not file during this period, there will be an extension of the nomination period for that specific office until Wednesday, December 13, 2023, at 5:00 p.m. for anyone other than the incumbent.

Additionally, candidates for Superior Court Judge must file a mandatory Declaration of Intent form with the Registrar of Voters beginning October 30 through November 8, 2023, at 5:00 p.m. For information regarding filing for elective office call: (209) 525-5201.

**NOTICE IS FURTHER GIVEN** that pursuant to current California election laws, all actively registered voters shall receive a vote by mail ballot. Vote centers will begin opening 10 days prior to Election Day to provide in person voting services. Language and accessibility assistance will be available at all voting locations. Secure ballot drop boxes will be available 29 days prior to Election Day. Vote center and secure ballot box locations, dates and times will be listed in the county voter information guide and posted on [www.stanvote.com](http://www.stanvote.com). All vote centers and the county elections office will be open 7:00 a.m. to 8:00 p.m. on Election Day, Tuesday, March 5, 2024.

**NOTICE IS FURTHER GIVEN** that ballots from the March 5, 2024, Presidential Primary Election are to be tallied and the canvass of the vote will be conducted at the Stanislaus County Registrar of Voters Office (central counting place) at 1021 "I" Street, Suite 101, Modesto, California, commencing no later than 9:00 a.m. March 7, 2024.
