## STANISLAUS COUNTY ADOPT A VOTE CENTER APPLICATION

- Select vote center locations will be open for early voting beginning 10 days before Election Day (a total of 11 days) from **8 am to 5 pm**.
- All vote centers will be open for early voting the **Saturday, Sunday, and Monday** before Election Day (a total of 4 days) from **8 am to 5 pm**.
- All locations will be open on Tuesday, **Election Day**, from **7 am to 8 pm**.
- Your organization must provide up to **5 volunteers per day** to serve at a vote center.
- There must be a bilingual Spanish-speaking worker at every vote center each day.
- A **\$150 stipend** will be paid **per volunteer position** each **early voting day** and **\$235 for Election Day**, which can be donated to your organization.

Volunteers must meet eligibility requirements: 18 years of age or older, U.S. citizen & registered voter or legal permanent resident, can read and write English. All volunteers will be required to attend a 3-hour training class.

- Receive an additional stipend of **\$120 per day** by providing a facility that can be used as a vote center and meets the criteria.
- Locations are surveyed in advance for ADA compliance, connectivity, and power supply for equipment.
- Important considerations include but are not limited to proximity to public transportation, population centers, language minority communities, and access to free and accessible parking.

**Last minute replacements are difficult to find. Please apply only if your organization is committed to serving.**
