**BE A PART OF STANISLAUS COUNTY'S
ELECTIONS TEAM**

We need committed members of the community to work at vote centers during elections in Stanislaus County. All vote centers are open 3 days, before Election Day, and several are open 10 days before Election Day. This includes weekends. On early voting days vote center hours are 8 a.m.-5 p.m. Election Day hours are 7 a.m.-8 p.m.

HOW TO GET INVOLVED:

SIGN-UP AS A VOLUNTEER

Volunteers must be at least 18 years old, a U.S. citizen, and a registered voter in California or a non-citizen with permanent resident status otherwise eligible to vote. Volunteers receive a stipend starting at \$150 for early voting days and \$235 for Election Day.

Election Day can be long (14+ hours), busy and occasionally stressful. Volunteers must:

- Attend training.
- Have a reliable email address that is checked regularly.
- Be able to lift 20-30 pounds.
- Be in good physical condition that allows sitting and/or standing for long periods of time.
- Be able to follow written and verbal instructions.
- Have reliable transportation to training class and to their assigned voting location on assigned days.

Individuals who have concerns about the physical requirements because of a medical condition are encouraged to contact the Elections Office about possible accommodations.

Typical tasks include:

- Greet voters at early in-person voting sites.
- Setup and take down voting equipment
- Ensure an efficient flow of voters.
- Accept ballots at curbside ballot drop-off locations.
