

## 1% Post Election Manual Tally Report

West Stanislaus County Fire Protection District Special Election – August 29, 2023

Pursuant to California Elections Code 15360, The Stanislaus County Registrar of Voters conducts a random drawing to determine which ballots will be hand tallied in the 1% Manual Tally to verify accuracy of the ballot counting equipment. The random draw was conducted on **August 30, 2023**, at 11:00 a.m.

- For vote by mail ballots: 1% of batches scanned at the central count location during the semifinal canvass were randomly selected.
  - Central count utilizes three color coded scanning groups: Orange, Yellow and Green.
  - All ballots for this special election were scanned using the Yellow scanning group.
  - All ballots cast at this special election were vote by mail.

Question:

To preserve public safety and ensure essential fire protection and emergency medical response in our community by providing funding for: reserve funds; apparatus, vehicle, and fire stations; volunteer firefighter compensation; and firefighter training shall the West Stanislaus County Fire Protection District Ordinance #2023-01 be adopted, authorizing a special tax levy, including \$125 annually per residential unit, raising approximately \$540,000 annually until repealed, with annual audits, and all money staying local?
